- b) Review, discussion and possible action regarding interview and offer process and procedures related to executive director position.

**5) CALL TO THE PUBLIC**

The Joint Committee may make an open call to the public during the meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the Joint Committee on any issue within its jurisdiction. Pursuant to A.R.S. § 38-431.01(H), members of the Joint Committee are not allowed to discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action. However, the Joint Committee may ask staff to review a matter or may ask that a matter be placed on a future agenda.
